(1) This Amended Form 144 amends the Form 144 filed by Repsol YPF, S.A. on August 5, 2010 (the "Original Form 144") to reduce the number of shares of Class D common stock, either in the form of shares or American Depositary Shares (each representing one Class D share of common stock) (together, "Common Stock"), of YPF Sociedad Anonima to be sold by Repsol YPF, S.A. set forth in 3(c) of the Original Form 144 and indicate that such Common Stock should be aggregated with certain sales of Common Stock by Repsol Exploración, S.A., a 100%-owned subsidiary of Repsol YPF, S.A. ("Repsol Exploración"), as described in Note 2 below. In addition, the aggregate market value set forth in 3(d) of the Original Form 144 and the approximate date of sale set forth in 3(f) of the Original Form 144 have been amended herein.

(2) The shares of Common Stock to be sold by Repsol YPF, S.A. should be aggregated with the shares of
